SOLICITOR'S REPORT

Mr. Repak, reported on recently signed Act 4 of 2016, pertaining to background checks. Act 153 of 2015 amended the Child Protective Services Law (CPSL) to require that background checks be renewed every 5 years. Act 4 brings the School Code in alignment with this CPSL requirement so that the applicant can use the background

check and retain it up to five years. Rather than renewing the clearances every year for applications, applicants can use that one clearance for prospective employment for up to five years.

One minor issue is that the 3M Cogent online system is not caught up. Until PDE establishes a system that will retain the CHRI report for five years, districts will have to manually retain that information. Also, for applicants that were required to obtain name checks for the FBI, PDE disclosed that name checks will also last for five years.
