RESOLVED: That the Board of Directors hereby approves renewal of the contract with Nutrition, Inc., to provide Food Service Management Services for the district's cafeterias for the 2020-2021 school term. This contract is for a period of one year beginning on July 1, 2020 through June 30, 2021.

2020-2021 BUDGET FOR ADMIRAL PEARY AREA VOCATIONAL-TECHNICAL SCHOOL

RESOLVED: That the Board of Directors hereby approve the 2020-2021 budget as presented and endorsed by the Superintendent's Advisory Committee and the Joint Operating Committee of Admiral Peary Area Vocational-Technical School.

VISION INSURANCE PROGRAM

RESOLVED: That the Board of School Directors approve a two-year agreement effective July 1, 2020 with *Vision Benefits of America* to provide vision insurance coverage for all eligible employees. This benefit plan will continue to be administered in compliance with all employment agreements.

RE-ENACTMENT OF PER CAPITA TAX UNDER SCHOOL CODE OF 1949

RESOLVED: That the Board of School Directors of the Penn Cambria School District, Cambria County, Pennsylvania, under and by virtue of Section 679 of the School Code of 1949 P.L. 30, and its supplements and amendments, declares that the resolution by which a per capital tax had been levied for the school fiscal year ending June 30, 2020, for general school purposes in the sum of FIVE (\$5.00) DOLLARS upon each and every person residing in the Penn Cambria School District of the age of eighteen (18) years and over is hereby re-enacted without change for the school fiscal year beginning July 1, 2020 and ending June 30, 2021.

RE-ENACTMENT ACT 511 TAXES

RESOLVED: That the Board of School Directors of the Penn Cambria School District, Cambria County, Pennsylvania, under and by virtue of the authority vested in it by Act No. 511 of the General Assembly of the Commonwealth of Pennsylvania, approved December 31, 1965, as amended, declares that the resolutions levied for the school year ending June 30, 2020, for general school purposes, are hereby re-enacted without change for the school fiscal year beginning July 1, 2020, and ending June 30, 2021. The Act 511 taxes include:

- i. Real Estate Transfer Tax (.5%)
- ii. Earned Income Tax (.5%)
- iii. Per Capita Tax (\$5.00)
- iv. Flat Occupation Tax (Gainfully Employed Tax) (\$5.00)
- v. Local Services Tax (formerly Occupation Privilege Tax) (\$5.00)

AUTHORIZE BUSINESS ADMINISTRATOR TO INVOICE FOR SPECIAL EDUCATION SERVICES

RESOLVED: That the Board of School Directors hereby authorizes the Business Administrator to prepare invoices and bill school districts for services provided to special education non-resident students attending Penn Cambria in 2019-2020.

TRANSPORTATION CONTRACT

RESOLVED: That the Board of Directors pass a resolution to make payment to Wilkinson Bus Lines, Inc. for the balance of the 2019-2020 school year for periods when schools are not in session due to the COVID-19 pandemic for a total of 178 days. Amounts will be billed and paid at the rate of 100% of the 2019-2020 rates for contracted services. Total compensation for the 2019-2020 fiscal year will not exceed 180 days. This payment is conditioned upon the transportation vendor complying with subsection (2) of Section (L) of Senate Bill 751 (24 PS 1501.8) and retaining their staff for payment and benefits during this time.

PLAN AMENDMENTS TO 403 (B) PLAN

RESOLVED: That the Board of School Directors adopt plan amendments to the Penn Cambria School District 403(b) Plan based on the rule changes stated in the Coronavirus Aid, Relief, and Economic Security (CARES) Act to include new coronavirus-related distributions and enhancements to loan provisions.

SOLICITOR'S REPORT

Ms. Krystal Edwards updated the Board of Directors regarding changes due to the Coronavirus affecting school districts. On May 8, 2020, Governor Wolf signed House Bill 360, which provides additional time for school employees to renew their FBI fingerprint-based background checks because of the pandemic. Employees will now have until the end of the year to get their Federal Bureau of Investigation (FBI) background certifications.

MILLAGE LEVY FOR 2020-2021 FISCAL YEAR

RESOLVED: The Penn Cambria School District Board of Directors, in Regular Session assembled, that for the purpose of providing revenue for said district for fiscal year beginning July 1, 2020 and ending June 30, 2021, a tax of fifty-five and fourteen hundredths (55.14) mills of all property in said district upon which Cambria County tax is levied and assessed. Properties levied and assessed within the District lying in Blair County shall be taxed at six and seventy-nine hundredths (6.79) mills. These mill rates are in compliance with Section 24 of the Public School Code 6-672.1 (re-balancing). This resolution adopted this 19th day of May 2020. These mill rates reflect no tax increase from the 2019-2020 fiscal year for properties levied and assessed within Cambria County.
