Following the Pledge of Allegiance, the following were the items of business and discussion.

HEARING OF VISITORS - There were no questions, concerns, comments, related to school business.

STUDENT REPORTS TO THE BOARD

Mrs. Kaitlyn Kalwanaski, High School Principal, introduced Aaron Duke and Mason McCarthy as the two student representatives reporting to the Board of Directors.

Aaron Duke reported to the Board of Directors that there has been a good amount of school spirit at the high school. Trivia Fridays have been integrated back into lunches and students are really enjoying it. Aaron recommended the creation of posters to show students that may not have had the opportunity to hear the announcements, how they can join school clubs and activities. The main concern at the high school is regarding COVID-19 related quarantines; students and teachers that are quarantined are struggling to get caught up, causing high stress levels.

Mason McCarthy informed the Board of Directors that there was a big turnout of students who participated in and loved the first school spirit week and are looking forward to Red Ribbon week. Mason also stated that there has been a vast improvement to school lunches and recognized Mrs. Focht, Food Service Director, for her efforts. He suggested having pep rallies for all high school activities, not just sports, so that all students can be recognized. Mason asked permission from the Board for the Spanish Club to attend Fright Night at Kennywood, following COVID-19 protocols.

Mr. William Marshall thanked the students for reporting school climate and added that the Leadership Team will be meeting this week to review the students' requests. Mr. Marshall noted that Fright Night at Kennywood this year will be held during the day and that there are concerns of student commitments to clubs and extracurriculars.

ADMINISTRATOR REPORT

Mr. Dane Harrold, Principal grades 5-8, provided middle school updates to the Board of Directors regarding the new school year, including: 102 out of 107 families participated in the 5th grade back to school night; information provided by the PA Youth Survey on school climate, academics, and resources; Panther PAWS Rewards given to students that go above and beyond; the popcorn fundraiser raised over \$22,000 and those funds will be used for field trips and activities, any excess funds will stay with each grade level until funds are depleted; theme days and pep rallies are helping to improve school climate; thanked Mrs. Kalwanaski and Mr. Shingle for allowing the high school band to perform at their pep rally; Positively P.C. Proud Mural that Mrs. Weakland and students completed in the cafeteria that includes pictures and newspaper clippings of student recognitions; and the usage of Canvas for quarantines due to COVID-19 has made it less challenging for students due to the opportunity to interact with teachers. Mr. Harrold concluded that middle school students and staff are doing a really great job and that he is extremely proud of all of them.
