Minutes of the September 29, 2022 Board of Education Meeting

## HOURLY WAGE INCREASE FOR NON-CONTRACTED, CONFIDENTIAL EMPLOYEES

**RESOLVED:** That the Board of Directors approve hourly wage increases for non-contracted, confidential employees equal to those approved in the MOA with PCESPA in Resolution #1.

Mr. Marshall, Superintendent, commented that the approved Memorandum of Agreement will be voted on by PCESPA. If approved, hourly wages for all PCESPA employees will be increased by \$2.10 per hour across the board, except for Health Room Assistants who received a wage increase in February 2022. The starting hourly wage will increase from \$10.40 per hour to \$12.50 per hour.
