PCP operates a school-wide Title 1 program which means that our Title 1 funds are used to serve all children in a school. All staff, resources, and classes are part of the overall school-wide program. The purpose is to ensure **all students** – especially those considered most academically at-risk – are able to attain academic proficiency based upon state academic standards. Funds are used to provide reading specialists and other intervention services at PCP, and to provide supplemental academic resources.
