Mr. Repak then informed the Board of Directors on a newly signed bill that repeals a section of the Public School Code of 1949, which prohibits a teacher from wearing any garb, mark, emblem or insignia that would indicate their religion while teaching. Educators who break the rule can be disciplined and even removed. The bill will go into effect in early January.

ADMINISTRATOR'S REPORT

Mrs. Jeanette Black, Assistant to the Superintendent, provided an update to the Board of Directors on recent academic data and test scores.

"We are working to prepare productive citizens in a safe and positive environment that promotes excellence in academics, the arts, and athletics.

We've been concentrating on continuing to improve that safe and positive environment over the last three years as a result of COVID and the challenges in society. Tonight, however, I wanted to take an opportunity to talk a bit about our focus on striving for excellence in academics as well.

Please know that academics can be a broad area, especially if we're talking about preparing productive citizens. However, how do we know how prepared our students are? Grades are subjective, an "A" is not equal everywhere. Standardized assessments can tell us this. Our students are going to be measured against others when competing for college and career opportunities, and it is our job to be sure they are as well prepared as others. We must look at lots of different data, not just one snapshot, one grade, or one test. However, if a student can score proficient or advanced on a state assessment, that tells us they have a solid foundational knowledge in that subject area and sometimes much more than foundational knowledge. It also tells us they can think, and problem solve to some extent, since questions are often difficult and complex.

Penn Cambria Reading and Math PSSA scores in grades 3-8 are inconsistent. In some grade levels we are exceeding state averages, but in others we are below state averages. We have areas where we can see room for improvement such as fractions in grade 4 or geometry concepts in grade 5, but we also see areas of strength.

For example, our 8th grade averages in every reporting category in every subject (ranging from physical science to functions in math, to conventions in English) exceed the state averages.

At the high school, our percentage of first time Keystone testers in 22-23 scoring proficient or advanced was significantly higher than the state average for first-time testers in 22-23.

Achievement data is important, but to me as a public educator, growth data is even more important. Are students learning and growing at an appropriate rate, whether they are a high achiever or a low achiever? PVAAS growth data helps answer that question.

At PC Intermediate, we exceeded growth standards in both Language Arts and Science, met the growth standard in Math, and met or exceeded the growth standard for Students with IEPs and students who are economically disadvantaged in all three subject areas as well.

At PC Middle School, we exceeded the growth standard in Language Arts, Math, and Science and exceeded the growth standard for students with IEPs and students who are economically disadvantaged in both Language Arts and Math.

At PC High School, we exceeded the growth standard in English, Algebra, and Biology and exceeded the growth standard for students with IEPs and students who are economically disadvantaged in all three subject areas as well.

While we always have room to improve, this growth data shows that students are learning important foundational skills to help them be productive citizens, no matter what their future might hold."

Mr. Monica inquired about state rankings.

Mrs. Black responded that the Future Ready Index shows how each school is doing in multiple categories, and not overall.

ANNOUNCEMENT

Mr. Marshall stated that he has worked with Mr. Roberts and Mr. Pyo for the past seventeen years and that it has truly been an honor. Both have allowed the administrators to take lead and have impacted thousands of students and community members over the years. Their service to Penn Cambria School District is greatly appreciated!

Mr. Sheehan mirrored Mr. Marshall's statement and thanked Mr. Pyo and Mr. Roberts for always supporting him.

Mr. Pyo concluded that it has been an honor to serve Penn Cambria School District.
