#### **NEW BUSINESS**

A motion was offered by Mr. Dziabo, seconded by Mr. Monica, and approved unanimously by roll call vote, to accept the following resolution:

# APPOINT SUPERINTENDENT OF SCHOOLS

**RESOLVED:** That the Board of Directors approve Jaime Hartline as the Superintendent of Schools for Penn Cambria School District at a rate of \$117,000 for a 5-year term, per the terms and conditions of the agreed upon contract.

# **DIRECTOR OF PUPIL SERVICES**

**RESOLVED:** That the Board of Directors approve to create the temporary position of "Director of Pupil Services" until such time as the position is abolished.

A motion was offered by Mr. Monica, seconded by Mr. Drenning, and approved unanimously by voice aye vote, to accept the following resolution:

### APPOINT DIRECTOR OF PUPIL SERVICES

**RESOLVED:** That the Board of Directors approve Jaime Hartline to the temporary position of "Director of Pupil Services" from a time to be determined based upon the individual's release date through July 31, 2024. Said individual will be provided a prorated salary of \$112,000 and all benefits as provided within their approved Superintendent Contract during this time. Upon commencement of Jaime Hartline's Superintendent role on August 1, 2024, said position of "Director of Pupil Services" will be abolished.

**COMMENTS** - Attorney Repak explained that the reason for creating the temporary position of Director of Pupil Services is provide overlap between Mr. Marshall's and Mr. Hartline's start and end dates for the superintendent position.

Mr. McCarthy congratulated Mr. Hartline on his appointment to the superintendent vacancy.

Mr. Hartline stated that he is honored and humbled to introduce himself as the next Superintendent of Schools for Penn Cambria.

"Obviously from being a product of this district, I understand a lot of the responsibilities that come along with the position and the current circumstances and challenges that face the district. However, I am honored to be in front of that project. I am going to work with the staff and students alike, and our community, to make sure we put our best foot forward, to continue the excellence that Penn Cambria has already established.

My wife and I were talking on the way here, and she asked who all was going to be at this meeting; I replied that I had no idea. Then, I walked in to see the administrators, teachers, and I won't put her on the spot, but one of my Hollidaysburg teachers is also in attendance here this evening.

This is a nice warm feeling and family atmosphere that I am looking forward to. I am very happy and excited to be here and can't wait to get started after finishing my responsibilities in Hollidaysburg. Thank you."
