HEARING OF VISITORS - There were no questions, concerns, comments, related to school business.

Mr. Sheehan announced that due to a scheduling conflict, the solicitor's report and executive session will take place immediately and the agenda will then continue as presented.

SOLICITOR'S REPORT - Ronald Repak explained to the Board of Directors that Act 34 Hearings are required when school districts are planning new construction or an addition that is twenty percent or more of the area of an existing district building. Though school districts are no longer reimbursed from the state through PlanCon, these codes are still intact. The codes require school districts to advertise twenty days in advance of the hearing. The advertisement should include the location where the proposed bid amount and reason for the construction is posted. If at any time the approved budget amount changes, the school district must repost with the updated information. Attorney Repak complimented Penn Cambria on how they have been doing a nice job of notifying the public regarding where the money is coming from and what it is being used for.
